



Workshop: Patents on plant genes - a lockdown for conventional plant breeding?

Wednesday, 16 November 2022, 17h – 19h CET, online

The EU Parliament has adopted several resolutions against patents on plants derived from conventional breeding (EP Resolution on the patenting of essentially biological processes, 10 May 2012 (2012/2623(RSP)), EP resolution on patents and plant breeders' rights, 17 December 2015 (2015/2981(RSP)), EP Resolution on patents and plant breeders' rights with a view to submitting a written statement to the Enlarged Board of Appeal of the European Patent Office (case G3/19 (2019/2800(RSP))).

However, the European Patent Office (EPO) still continues to grant patents which comprise plants derived from conventional breeding methods. Just recently, the first patent was granted by the EPO under a new rule which is supposed to exclude patents on plants and animals derived from conventional breeding (Rule 28(2), European Patent Convention, EPC), but apparently opens several loopholes: The patent, EP3560330, granted to KWS, covers maize with improved digestibility. It claims plants with randomly mutated genes and their harvest. It covers, in addition, the usage of naturally occurring genetic variations for conventional breeding.

This patent was exposed by a recent report, published by the international organisation *No Patents on Seeds!* (<https://www.no-patents-on-seeds.org/en/report2022>). This report also shows that many further patent applications are pending. In short, the companies, to escape the new Rule 28(2), EPC, changed their strategy by no longer specifically claiming processes for breeding. Now they simply claim the usage of genes and gene variations as found in existing varieties and seed banks or caused by random mutations.



These patents cover all usages of the genes. In the end, no matter if genetic engineering (genome editing) or conventional breeding is applied, the access to the biological material needed for all kind of breeding can be controlled, hampered or blocked. If this development is not stopped, freedom to operate for traditional breeders will soon become a thing of the past.

In the workshop, an overview is given on latest developments on seed patents in Europe by *No Patents on Seeds!*.
